





The feelings and the memories were made possible by the members of this club, the manufacturer of these cars, and by the people who have served to make our country what it is today.

## ***St. Louis Corvette Club Meeting November 7, 2006- Hessler's Pub***



The meeting was called to order by President Rick Frierdich at 7:05 pm. The Pledge of Allegiance was recited by all. All club officers and chairpersons were introduced.

**Current:** Article I, Section 2: **PURPOSE OF THE CLUB**

**Purpose:** To enjoy the Corvette through association with other Corvette owners. To have fun on many levels through social events, road trips, car shows, charity events and competition as each person wishes. To actively promote and work for the advancement of “Saint Louis Corvette Club” and its activities. To respect the differences and wishes of each Saint Louis Corvette Club member.

***Proposed Revision:*** Article I, Section 2: **PURPOSE OF THE CLUB**

**Purpose:** To enjoy the Corvette through association with other Corvette owners. To have fun on many levels through social events, road trips, car shows, charity events and competition as each person wishes. To actively promote and work for the advancement of “Saint Louis Corvette Club” and its activities. To respect the differences and wishes of each Saint Louis Corvette Club member. To promote, and participate in, the activities of NCCC.

**Current:** Article III, Section 2: **MEMBERSHIP STATUS** (5<sup>th</sup> bullet)

NCCC Membership: Any person who has paid dues to the NCCC and abides by the by-laws will be extended all of the rights and privileges offered by the NCCC.

***Proposed Revision:*** Article III, Section 2: **MEMBERSHIP STATUS** (5<sup>th</sup> bullet)

NCCC Membership: All Saint Louis Corvette Club members will be NCCC members and will be extended all of the rights and privileges offered by the NCCC.

**Current:** Article III, Section 3: **MEMBERSHIP FEES**

Membership dues for Corvette owner members shall be **\$20.00** per person plus NCCC dues and an optional \$10.00 for “NCCC spouse” upon application for membership. This fee is to be paid prior to the November meeting. New members joining between September 1 and November 1 will be considered paid through November of the following year. Honorary members and club sponsors are exempt from these fees.

**Proposed Revision:** Article III, Section 3: **MEMBERSHIP FEES**

Membership dues for Corvette owner members shall be **\$20.00** per person plus NCCC dues upon application for membership. This fee is to be paid prior to the start of the November meeting. New members joining between June 1 and August 31 will pay one half (½) current membership dues plus NCCC dues upon application for membership. New members joining between September 1 and November 1 will be considered paid through November of the following year. Honorary members and club sponsors are exempt from these fees.

- d. smoking during meeting
- e. does not own Corvette for 1 year
- f. mis-use of office
- g. mis-use of private club information
- h. driving under influence at club events/meetings

**Current:** Article VI, Section 8: **DUTIES OF NCCC GOVERNOR**

The Governor shall serve as the Club representative to the National Council of Corvette Clubs, Inc. He/She shall keep members informed of all important issues being acted upon including any changes to the rulebook, etc. The Governor shall keep members advised of the events being held within the Region and should encourage members to attend other club's events. The Governor shall also remind members of the renewal date for NCCC membership. He/She shall process all renewal forms as received from the Membership Officer and shall be responsible for signing new NCCC members within the club. The Governor shall be responsible for working with the Regional Competition Director for scheduling events and for submitting completed event results as required by the Regional Competition Director.

**Proposed Revision:** Article VI, Section 8: **DUTIES OF NCCC GOVERNOR**

The NCCC Governor shall be appointed by the board. The Governor shall serve as the Club representative to the National Council of Corvette Clubs, Inc. He/She shall keep members informed of all important issues being acted upon including any changes to the rulebook, etc. The Governor shall keep members advised of the events being held within the Region and should encourage members to attend other club's events. The Governor shall also remind members of the renewal date for NCCC membership. He/She shall process all renewal forms as received from the Membership Officer and shall be responsible for signing new NCCC members within the club. The Governor shall be responsible for working with the Regional Competition Director for scheduling events and for submitting completed event results as required by the Regional Competition Director.

**Current:** Article VI, Section 13: **DUTIES OF ACTIVITIES CHAIRPERSON**

The Activities Chairperson shall encourage members to plan trips, social gatherings and events. Activities Chairperson shall also help coordinate a yearly calendar of events, picnic, and Christmas party, along with the Vice President.

**Proposed Revision:** Article VI, Section 13: **DUTIES OF ACTIVITIES CHAIRPERSON**

The Activities Chairperson shall be appointed by the board. The Activities Chairperson shall encourage members to plan trips, social gatherings and events. The Activities Chairperson shall also help coordinate a yearly calendar of events, picnic, and Christmas party, along with the Vice President.

# Why NCCC ?

There are several benefits in joining the nccc with the foremost reason being the \$1,000,000 insurance policy for club sponsored events.

In addition to the insurance coverage there is a magazine named “blue bars” that is published 4 times a year. This magazine covers news from all 16 regions around the country and also has some event coverage.

The nccc raises money each year to contribute to worthy organizations such as the national kidney foundation – last year over \$121,000 was donated to this organization.

There is a competition program that includes such events as timed races (autocross – both high and low speed), drag races, ralleys, concours, icekhanas, economy runs and funkhanas. Participants earn points based on their order of finish in each event. There are both regional and national points that can be earned. To be a national point leader means you must attend many, many events and spend a great deal of time and money while on the road. We can hold these type of events but we have to keep in mind that these events are attended by many corvette’s who are after points and we have to be exact in what we do at these events.

The nccc also hosts a national convention every year with clubs submitting proposals to the governors to vote on. Next year the national convention is in Nashville, tn. With Tulsa, ok. Being the only club to date to submit a bid for 2008. these conventions generally last about a week with most of the events listed above and partying and other social activities.
