







## St. Louis Corvette Club Meeting

*February 6, 2007 – Hessler's Pub*

The meeting was called to order by President Bill Dotson at 7:05 PM. Bill welcomed everyone. The Pledge of Allegiance was recited by all. The club boasted record attendance with 43 members and 1 guest present. Bill introduced the board of officers and current chairpersons. Everyone was reminded to sign in and to purchase 50/50 tickets from Sergeant at Arms Roger Ruengert.

### **Guest**

Bill Dotson introduced guest Pam Bircher and thanked her for coming to the meeting. Pam recently attended the 2006 Club Christmas party and members enjoyed seeing her again.

### ***Treasurer's Report***

Jean DuPont made a motion to accept the treasurer's report as presented in the February newsletter. Sara Gibson seconded the motion. It was approved by the membership.

### ***Secretary's Report***

*President Bill Dotson noted the following corrections to be made to the January 2<sup>nd</sup> minutes: a) that June Huch should be shown as the Thursday Night Dinner Coordinator rather than Bill Dotson, and b) that the club by-laws will not be published on the club website as previously mentioned.*

*Judy Dooley made a motion to accept the minutes from the January 2, 2007 meeting as published in the February newsletter and with the previously noted corrections made. The motion was seconded by Carl Ballinger and approved by the membership.*

### ***Membership Report***

Patty Craig announced that there are 54 members including Frank and Terri Ashmore who paid dues this evening, 2 honorary members, and 3 mailing members. Patty congratulated those club members celebrating February birthdays and anniversaries.

Patty reminded everyone of the Valentine Brunch scheduled for Sunday, February 18. This is a pre-paid event and a sign up sheet was provided for those interested in attending.

### **National Corvette Museum Ambassador's Report**

Judy Dooley reported on Museum accomplishments in 2006:

- a) 27,000+ membership
  - b) 9 raffles which brought in \$1.4 million
  - c) 1,100 R8C Museum deliveries
  - d) 50 Xperience deliveries
  - e) internal production of 2 DVDs
  - f) update of new exhibit reader boards
  - g) addition of 2 interactive displays in the engineering area
- 2007 Museum goals include increasing membership.

The C5-C6 Bash will be held at the museum in April (26-28). A Victory Red convertible will be raffled at that time. The car comes with a 3LT package and includes Museum delivery. Judy has \$10 raffle tickets available.

Judy noted that building expansion at the Museum has not yet begun. Building will take place in stages, as money comes in. Bank loans will not be taken out for building projects.

### **National Council of Corvette Clubs Governor's Report**

Carl Ballinger did not have much news to report as this is a slow time of year. He has NCCC patches available for purchase for \$3.00. The first Governors' Meeting will be held at Westport Plaza on Saturday, February 24, 2007. The Midwest Regional session will be held in the morning followed by the National Governors meeting in the afternoon. Carl noted that '07 events are posted on the NCCC website and the regional website (mwregion.com).

NCCC events are open for the club's consideration. The Midwest Regional Awards Banquet will be held in the Chicago area on Saturday, March 10<sup>th</sup>. Cost is \$55 per person plus lodging expense. The NCCC Convention will be held in Nashville this year (*June 16-22*). Tulsa, OK is bidding on the '08 NCCC Convention.

## Old Business

American Cancer Society - The club's recent donation of \$1,000 qualified us to receive 75 bunches of daffodils (through the ACS' Daffodil Days fundraiser) with the club's logo being included on the ACS website and future ACS publications. The flowers would be available on March 9, the Friday following our March club meeting. In lieu of receiving the daffodils, it would be possible to receive stuffed teddy bears but these would not include the logo publicity. Certificate of Appreciation – In response to Bill's inquiry as to former sponsor and club member Jim Wand's current place of employment, members acknowledged that he is working at Suntrup Select, next to Sinclair Ford. The club's certificate of appreciation from 2006 will be delivered to him.

### New Business

Club's Non-Profit Status – Treasurer Jerry Fain reported that the club's application for non-profit status in the state of Missouri has been processed for the current year. This renewal is to be done annually.

Monthly Desserts – Volunteers are in place for all months of the current year.

Blue Bars publication – Carl Ballinger asked that members provide him with any changes in mailing addresses to ensure receipt of the Blue Bars magazine.

GM Recall – Bob Woods shocked everyone with his announcement of a pending GM recall of yellow corvettes for repainting. It didn't take long for everyone to realize that this was just another famous "Woods-ism" and that yellow corvette owners need not fear!

NCM "An Anniversary Affair" – Theresa Luebcke announced that "An Anniversary Affair" will be held at the National Corvette Museum from June 22 – 23, 2007. The event is not limited to anniversary cars (25<sup>th</sup>, 35<sup>th</sup>, 40<sup>th</sup>, 50<sup>th</sup>). In the wake of Bob Woods' announcement, Theresa stressed that yellow cars may attend the festivities. The event will include dinners and road tours.

Charity Proposal – Theresa Luebcke asked if the club had designated a charity for the current year. She then proposed that the club support the Corvette Museum building fund as our charity. Bill Dotson reminded members that support of the local veterans had been discussed at the January meeting but that the club could also consider potential support for the museum.

## Proposed revisions to the St. Louis Corvette Club By-Laws

### Article I Section 3: Club Name and Logo (New Section)

The club name, Saint Louis Corvette Club, and logo are the property of the club. Neither the club name nor logo can be displayed in any format or medium or be changed without Board approval. Examples of formats and mediums include, but are not limited to: clothing, banners, decals, hats, stationery, website, advertisements and gifts. Any use of the club name and/or logo prior to January 1, 2007 was acceptable. Any changes or additional uses of the club logo or name after January 1, 2007 must be approved by the Board.

### Article II, Section 3: Sponsor, change to read:

A Chevrolet dealership is the preferred club sponsor. However, the club sponsor can be any individual or firm whose intent is to promote a common interest in the Corvette community. The sponsor will contribute a dollar amount to the General Fund on an annual basis. This amount will be mutually agreed to by the Board and the Sponsor. The Sponsor will be allowed free advertisement at all club sponsored events, on our website, on our business cards, and any other place as agreed by the Board and Sponsor. No advertisement or display of a competing company to the Sponsor will be allowed.

Delete Article X, Section 1 as it is incorporated into the revised Article II, Section 3 above.

Article VI Section 11 - revise to read “A Charities Chairperson may be appointed by the Board” rather than “shall be appointed”...

Article VI Section 12 - revise to read “An Activities Chairperson may be appointed by the Board” rather than “shall be appointed”...

Article VI Section 13 - revise to read “A By-Laws Chairperson may be appointed by the Board” rather than “shall be appointed”...
