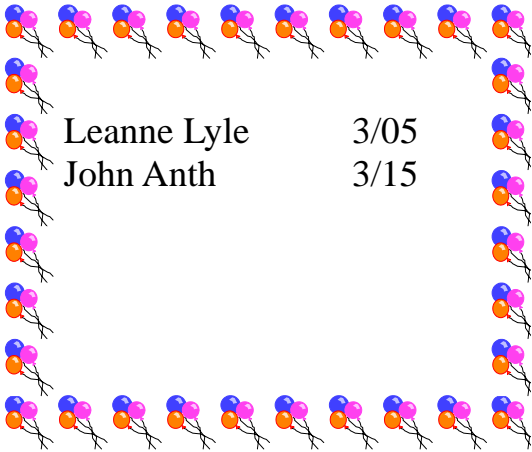
We still have a large number of weekends that are ripe for a road trip or other event. Put your thinking caps on and come up with an idea.

I look forward to seeing all of you at our March meeting.

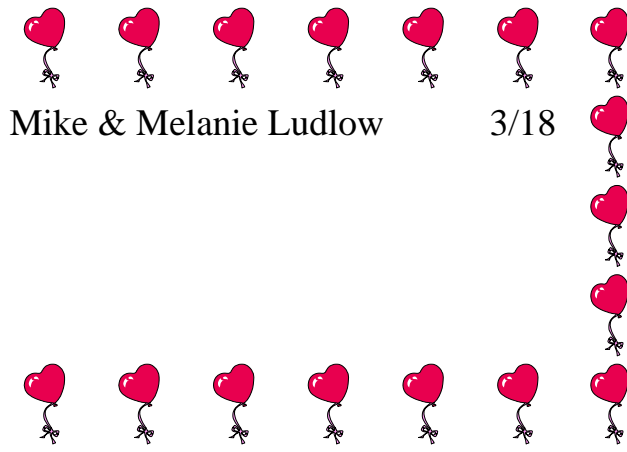

## St. Louis Corvette Club Meeting

*February 5, 2008 – Sunset Lakes Banquet Center*



The meeting was called to order at 7:15 p.m. by president Bill Dotson. The Pledge of Allegiance was recited. Bill welcomed everyone who had come out in the rain on Fat Tuesday/Super Tuesday for the evening's meeting. He introduced board members, committee chairpersons, National Corvette Museum ambassador Judy Dooley and NCCC governor Rich Luebcke. Unable to attend were membership chair Angie Bradford, webmaster Jerry Craig, and club sponsor Mike Dean from Lynch Hummer. Members were reminded to sign the attendance sheet and purchase 50/50 tickets.

### **National Council of Corvette Clubs Governor's Report**

Rich Luebcke gave a brief overview of the National Council of Corvette Clubs (NCCC). He said that many clubs are represented by NCCC and that the organization provides excellent support for participating car clubs. Many clubs join NCCC for the opportunity to be well-insured for club events. No other insurance companies provide the insurance coverage that K&K Insurance Company provides for NCCC. Rich distributed informative handouts detailing NCCC benefits and information from the NCCC Handbook. He also provided 2008 planners and NCCC lapel pins for club members. Rich reminded everyone of the next governors' meeting to be held in St. Louis at the end of February.

### **Charity Committee**

It had been the intention of the Charity Committee to decide on a charity/charities to support for the year at this meeting. Not everyone attending the January meeting received a charity nomination form. Forms will be distributed this evening. Members are asked to return their completed forms to Jan Murray prior to or at the March 4<sup>th</sup> meeting. Voting on selected charities will take place at the March meeting if possible but if more time is needed, voting may be postponed until the April 1<sup>st</sup> meeting. Completed forms may be mailed to Jan Murray.

### **Treasurer's Report**

Jean Dupont made a motion to accept the treasurer's report as presented in the February newsletter. Ruth Howard provided a second to the motion and it was approved by the membership.

### **Secretary's Report**

Patty Craig made a motion to accept the minutes from the January 20, 2008 meeting as published in the February newsletter. Jerry Fain provided the second to the motion and it was approved by the membership.

### **Membership Report**

There was no membership report given in Angie Bradford's absence. Bill Dotson acknowledged February birthdays and anniversaries as noted in the February newsletter.

### **National Corvette Museum Ambassador's Report**

Judy Dooley reported that the C5-C6 Bash will be held at the museum April 24–26, 2008. 400 are pre-registered as of this date. The banquet will honor Wil Cooksey upon his retirement as Corvette plant manager. Paul Graham, the new plant manager, will participate. Groundbreaking ceremonies for the new museum wing will also take place during the Bash week-end. A new ZR-1 will be displayed and the ZR-1 design team will attend.

Judy will share more information at the March meeting regarding club events that may be held at the museum. Bill Dotson noted that registration for the C4/ZR-1 gathering is now open. That event will be held May 8-10.

### Sunday, February 17 - Valentine Brunch

### Sunday, March 30 – Sponsor's Charity Event

Ideas were shared for the Lynch Hummer Charity Event to benefit the Albert Pujols Foundation. The event is tentatively scheduled for 10:30 a.m.-2:30 p.m. at Lunch Hummer. Planned activities (e.g. face painting) are needed for the children while they are waiting to participate in the off-road event. A photographer will be available to take digital photos of the children in club cars. Let Bill know if you have a business contact who might be able to donate merchandise/food for the event. Members will be needed to grill meat and help with lunch. Patty Craig suggested bringing the DVD "Cars" to play in case of inclement weather.

Ideas were shared concerning gift items for the event. Possibilities included contacting Mike Yaeger at Mid-America regarding a donation of Corvette hats or other Corvette items. "Hot Wheel" Corvettes could be a possibility. Bill Dotson said that club car cozies will be given to each father/son pair attending. Judy Dooley will contact Midwest Monograms to ask if they will consider donating Corvette or club items for the event.

It was decided to prepare a Corvette/Hummer coloring page for a coloring contest for the children. Celebrities in attendance at the event could be enlisted as contest judges. Crayons will be needed.

#### June 22 – 24 – Club trip to the National Corvette Museum

Marty and Judy Dooley are coordinating this event. Spaces have been reserved in the museum for our club cars. Jerry and Armynta Craig will take delivery of their new car on Monday, June 23. The return trip to St. Louis will be on Tuesday, June 24. Let Marty know if you are going so that he can make room reservations. Gary Murray asked if Boone Trail members could join us for the week-end and he was assured that they are welcome to attend. Marty will provide a schedule of week-end events later on.

#### **Old Business**

Business cards, club brochures, and DVD of 2007 activities are available. Angie Bradford has a small supply of square window decals. Jeff Craig will bring a sample of a long window cling with the club name to the March meeting for members' consideration. These may cost approximately \$5.

#### **By-Laws Proposal**

The proposal to change the by-laws concerning club expenditures was correctly printed in the February newsletter. Vice President Ron Hagenow explained his rationale for suggesting the proposal. Discussion also took place concerning a proposed yearly budget (see below). Members requested a reading of that portion of the by-laws being considered for change as well as the proposed amendment to the by-laws. After the reading, Randy Howard made a motion to adopt the proposed amendment to the by-laws. Jan Murray provided a second to the motion that was then approved by the membership. Dave Davidson questioned whether the by-laws call for a secret vote on changes to the by-laws. A hand vote is acceptable.

To recap, Article VIII, Section 4: Expenditures previously stated:

No obligation, debt or other liability shall be incurred in the name of the Saint Louis Corvette Club by any member of the club without specific approval of the Board.

The amendment to Article VIII, Section 4: Expenditures will now read:

- a) No obligation, debt or other liability shall be incurred in the name of the Saint Louis Corvette Club by any member of the club without specific approval of the Board.
- b) Any donation to a charity or other club expenditure greater than \$300 must be presented to the Board prior to a regularly scheduled monthly meeting. Discussion concerning the expenditure can take place during the regularly scheduled meeting however approval for the expenditure must be voted on at the next regularly scheduled meeting.

#### **New Business**

##### Budget

Bill Dotson proposed forming a budget committee for the purpose of establishing a yearly budget. He suggested that the committee be composed of the current treasurer and two additional ad hoc members.

A budget proposed by the committee would need to be presented to the membership for a vote. Bill circulated copies of a sample budget for members' consideration. Several members questioned how monies designated for charitable contributions would be reflected in a budget. Jackie Miget felt that a definite dollar amount should be included for charities. Bill said that a designated dollar amount based on annual club revenue would be earmarked for charities chosen by the club. Randy Howard gave the example that 15% of proceeds from club events could be earmarked for charitable contributions. Les Gibson recommended allocating a certain % of all monies made within the year to be given to the club's designated charities. Jan Murray asked how expenses incurred when planning charitable events would be determined and reflected in the budget.

Randy Howard and Charlie Miget volunteered to serve as budget committee members along with treasurer Sara Gibson. Bob Woods expressed his concern that the club was becoming too complicated with the formation of numerous committees. Bill Dotson said that anticipating continued club growth, structure and control of club finances are needed. He said that developing a budget will be a learning experience for the club.

Marty Dooley has a sign-up sheet for this trip, scheduled for July 31 – August 3.

#### Announcements

Rich Luebcke announced that the Elks Lodge in St. Peters, Missouri will be holding Mouse Races on Saturday, March 8. He will send out an email with more information on this event.

Bill encouraged members to email meeting night buffet menu suggestions to him for consideration. This evening's buffet featured mixed salad, jambalaya and rice, vegetable medley, oven potatoes, roast beef, rolls, and brownies. Cost of the buffet was \$12 per person, non-alcoholic beverages included.

Judy Dooley reminded members that \$10 raffle tickets are still available for the victory red '08 convertible to be given away at the museum on April 26.

#### 50/50 Raffle

Tammy Walker drew Chris Woods' winning ticket. Chris won \$55. Congratulations to Chris. Thanks to everyone for purchasing tickets.

Dessert – Thanks to Jeff and Patty Craig for bringing this month's cake. Les and Sara Gibson have volunteered to provide the March dessert.

Bonnie Ruengert moved to adjourn the meeting, seconded by Gary Murray. The meeting was adjourned at 8:15 p.m. The next regularly scheduled meeting will be held on Tuesday, March 4, at 7 p.m. at Sunset Lakes Banquet Center. (Doors will open at 5:30 and buffet will be served at 6:00 for those interested in eating prior to the meeting. Please note the earlier serving time to facilitate prompt start of meeting.)
